MIX RATIO:

To 100 parts by weight of Epibond®® 1534-A resin, add 100 parts by weight of Epibond 1534-B hardener. Mix both components thoroughly for several minutes.

CURE SCHEDULE:

Three days at 77°F (25°C), or gel at room temperature plus 20-30 minutes at 250°F (121°C).

STORAGE:

Epibond® 1534-A/B should be stored in a dry place, in the sealed original container, at temperatures between +2°C and +40°C (+35.6°F and 104°F). The product should not be exposed to direct sunlight. Under these storage conditions, and when supplied under Huntsman standard certification, this product has a shelf life of 2 years (expiration date may differ based on customer specification).

Material temperatures should be above 18°C (65°F) when mixing. After use, tightly reseal containers.
